

The Third party Inspection Agency should arrange to inspect all the materials within 3 days from the date of receipt of information from the concerned Engineers confirming the readiness to take up the inspection.
- 4. The agency shall assist the employer in discharging their functions.
- 5. Third party agency shall repeatedly check whether quality work is executed as per quantity put to tender.
- 6. The payment should be made to the Third Party Inspection Agency after submitting the inspection and test reports for the materials and works at site for the above said works.
- 7. In consideration of payment to be made by employer to the agency as here is mentioned Third Party Inspection Agency here by convenents with the employer to carry out the inspection of the all the materials used for the above said works and all material test to be carried out as per IS Standards.
- 8. Third Party Inspection Agency should confirm the quality of the work satisfactory completion as per sanctioned estimate and specifications.
- Inspection fees of 0.35% of the cost of the works executed to be paid to the Third Party Inspection Agency for the inspection of the materials and conducting of the tests at site of lab for the above said works.
- 10. Inspection reports should be submitted in three sets by the Third Party Agency to the employer with photographic evidence.
- 11. In event of dispute rising out of, or in relation to the agreement, the Hon'ble Vice-Chancellor, VTU, Belagavi shall decide over the dispute.
