AMENDMENT/ADDENDUM AGREEMENT

This Amendment Agreement ("First Amendment") to the Memorandum of Understanding (MoU) dated 17th February, 2023, is made and executed on 19th February 2024, between.

AND

Karnataka Law Society's Vishwanathrao Deshpande Institute of Technology, Haliyal, recognized under section 2(f) of UGC Act, 1956 having its registered address at Udyog Vidya Nagar, Dandeli Road Haliyal – 581329, Karnataka, India hereinafter referred "SPOKE" which expression shall wherever the context so submits mean and include its successors and assignees of the SECOND PART

For the purposes of this Addendum, RC and SPOKE shall be individually referred to as "Party" and collectively as "Parties".

WHEREAS Parties entered into an Amendment Agreement to <u>extend the agreement period</u>, with the following changes in terms and conditions detailed in the MoU dated 17th February, 2023.

NOW THIS FIRST AMENDMENT STATE AS FOLLOWS:

- a. Clause 12 of the MoU will be revised to indicate a mutual extension of the agreement period until Feb 28, 2025.
- b. Revision to Clause 8 of the MoU, Details of Incentives / Financial Assistance to Bridge Course Participants, incentive can be claimed until March 28, 2024. However, no incentives are permitted for claiming after this date.
- c. The listing price of Bridge Course 'Pragmatic Approach to Cyber
 Rs. 1200 (including GST) to Rs 240 (including GST) w.e.f June 2024
- d. Unless modified by any other Amendment or addendum, all other terms and conditions of the original MoU shall remain as it is till the currency of the Agreement.

- 1.2. All other terms and conditions of the Agreement which are not referred to expressly herein shall not be affected in any way whatsoever and shall therefore remain in full force and effect.
- 1.3. This Addendum may be signed on separate counterparts, each of which shall be an original, but all of which together shall constitute one and the same instrument and shall not be effective until RC and SPOKE have each signed at least one counterpart.
- 1.4. The Agreement and this Addendum constitutes the sole record of the agreement between the Parties in relation to the subject- matter. Neither Party shall be bound by any express, tactic or implied term, representation, warranty, promise nor the like not recorded herein or the Agreement
- 1.5. No addition to, variation, novation or agreed cancellation of any provision of the Agreement or this Addendum shall be binding upon the parties unless reduced to writing and signed by or on behalf of the parties.
- 1.6. Unless modified by this First Amendment, all other terms and conditions of the Service Agreement shall remain as it is till the currency of the Agreement.
